GENERAL RULES

1. The show is open to any bona fide 4-H or FFA member and entry must carry a 4-H or FFA identification tag.
2. The show committee shall, upon completion of the official weigh-in/check-in, determine classes for the event.
3. Market beef classes will be entered by shoulder height.
4. Market lamb and meat goats will be weighed.
5. The decision of the judge will be final.
6. A registration fee of \$5 per head for market lambs & meat goats and \$10 for each market beef will be charged. Make checks payable to Box Butte County 4-H Council.
7. The show committee, superintendent and Extension Educator reserve the right to remove from the grounds any exhibitor, animal or person that may be deemed objectionable to them.
8. Lambs will be free of active club lamb fungus or they will be dismissed from the grounds.
9. Barns will be open for participants to use. All exhibitors are expected to keep the stalls clean during the show and clean up the area at the close of the show. No bedding in the barns please.
10. Electricity may be limited. Portable generators are encouraged.
11. Dress: Show attire but NO t-shirts, halter tops or sleeveless shirts.
